

**Reciprocal Membership Agreement between the
European Society for Medical Oncology (ESMO)
and the
Cyprus Oncology Society (OEK)**

With reference to the discussions which have taken place between ESMO and OEK, ESMO is pleased to outline the basis for joint membership relationship.

Membership

- a) A joint membership will be established whereby any member of OEK who is in good standing (i.e. membership fee paid), wishing to join ESMO will benefit from an accelerated application process.
- b) Each Society will retain its own application and membership processes.
- c) OEK will encourage its members to apply for ESMO membership. ESMO will not require individual members to obtain sponsors for their membership application provided individuals are members in good standing of OEK.
- d) OEK members joining ESMO will have access to the range of membership benefits including access to OncologyPRO, ESMO's educational and scientific portal which offers a vast range of information sources including access to medical journals.
- e) ESMO will offer a reduced membership fee to OEK members qualifying for ESMO membership at the fee of 175 Euros. This annual membership fee will be reduced to €130 (discount of €45). These conditions are effective immediately and valid until end 2021, a review will take place autumn 2021 to agree future terms.
- f) Each Society will provide information and updates when necessary about membership terms and processes so that both parties understand the respective membership offers. The ESMO membership department will establish a regular dialogue with the OEK designated contact person in order to exchange information about administrative issues and member communications.

Communication

- a) ESMO and OEK will have mutual links on web sites (including logo) and details about the joint membership relationship with ESMO, including information about key ESMO membership benefits and most important web pages. ESMO will include information about the relationship in the membership section of esmo.org.
- b) OEK will promote ESMO activities of importance to the Cyprus oncology community e.g. promotion of the ESMO congress, travel grant opportunities and young oncologist initiatives (Fellowships and Preceptorship meetings) via each societies' communication channels.

ESMO National Liaison

- a) OEK has been invited to join the ESMO National Societies Committee and invited the Liaison who will be the key figure in the cooperation between ESMO and the OEK and will provide regular updates about activities.

Society Activities

- a) ESMO will share information with AAOC about any educational and scientific activities of relevance to members in Argentina, e.g. ESMO Fellowship Programme, ESMO Congress,
- b) OEK will offer free exhibition space to ESMO, should it be determined to have a booth at the national congress meeting.

Data Protection



Each Society's attention is drawn to the Data Protection Act 1998, Directive 95/46/EC of the European Parliament, the upcoming General Data Protection Regulation (GDPR) (Regulation (EU) 2016/679) and any national or European legislation or regulations implementing them or made in pursuance of them or any equivalent national legislation (the "Data Protection Requirements"). Each Society shall observe its respective obligations under the Data Protection Requirements that arise in connection with the performance of this Agreement and shall process and use personal data fairly and lawfully.

The details outlined in this agreement are not exhaustive, as the partnership evolves the Societies may identify new opportunities and projects on which to cooperate.



The Memorandum of Understanding runs until 31 December 2021. If not terminated by either party by 30 November 2021, the cooperation continues for the next two years (2022-2023).
